MINUTES

Monday, September 27, 1999

The twenty-third annual meeting of the Arkansas Association of College and University Business Officers (AACUBO) was convened by President David Martinson at the Don Reynolds Center on the University of Arkansas' campus at 1:30 p.m. The meeting was attended by 112 current and former business officers and associates representing colleges, universities, and other state agencies.

President Martinson introduced Dr. John White, Chancellor of the University of Arkansas, who welcomed the AACUBO conference to the University. Dr. White spoke briefly about the Don Reynolds facility, the foundation that funded it and the opportunities it provides. He also gave his thoughts on customer service and its role on the campus of the University of Arkansas.

President Martinson introduced the officers and board members for 1998-1999 year. He then introduced Vice-President Bobby Jones, who gave a preview of the program and addressed the issue of the 20% match for Reynolds grants.
